### Project/Program Presentations:

#### **BART - Warm Springs Extension**

A 5.4-mile extension of the existing BART Fremont line to a new Warm Springs station.

#### **Union City Intermodal Station**

Will provide enhancements to the intermodal station at the Union City BART Station to facilitate connections between existing and planned transit systems, including pedestrian and bicycle access.

#### **I-680 Express Lane**

Will provide SMART (formerly called HOT- High Occupancy Toll) lanes along I-680 from Route 84 in Alameda County to the Santa Clara County line.

#### **Dumbarton Corridor Improvements**

Will provide integrated transit service between the San Francisco Peninsula and Alameda County in the Dumbarton Bridge corridor.

#### **I-880 Mission Blvd. (Route 262) Interchange Reconstruction and Freeway Widening to the County Line**

Reconstruction of the I-880/Mission Blvd. (Route 262) Interchange, widening I-880 from south of Fremont Boulevard to Dixon Landing Road, re-striping I-880 between Dixon Landing Road and Route 237 (in Santa Clara County) and construction of a railroad grade separated wall.

#### **East-West Connector Project in Fremont and Union City**

In North Fremont and Union City, project will provide an improved roadway link between I-880 and Route 238 (Mission Boulevard)

#### **City of Fremont Paratransit Program**

Involves the development of Volunteers for Independence Program (VIP Rides Program), Older Driver Safety Awareness Program, South County Taxi Pilot Program, and Tri-City Travel Training Program.

## **What is ACTIA?**

The Alameda County Transportation Improvement Authority administers the Measure B half-cent transportation sales tax in Alameda County. ACTIA is delivering a fresh set of essential, voter-approved transportation infrastructure and service improvements to keep Alameda County moving.

Key areas of focus include mass transit projects and programs, transit villages, bicycle and pedestrian corridors, key highway projects to eliminate bottlenecks, and improvements to local connectivity.

## **A Local Business Commitment**

Delivery of projects and programs funded by Measure B are jointly accomplished through public and private agency partnerships. ACTA and ACTIA have a long-standing, historical commitment to revolving local funds within the communities from which they are derived. With over \$100 Million in transportation dollars each year, local business engagement is keystone to ACTA and ACTIA's success in delivery.

## **What is CAC?**

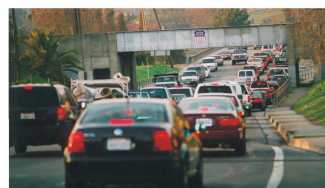
ACTIA is committed to community involvement.

Since 1986, the Citizens Advisory Committee has helped to promote accountability by serving as a liaison between ACTIA and the residents of Alameda County who fund Measure B through their tax dollars.

CAC members keep informed of the progress of Measure B programs and projects, discuss local community transportation concerns, and provide feedback to their representative communities.

## **Measure B: Alameda County's Transportation Sales Tax**

- First approved in 1986
- Reauthorized in November 2000 with 81.5% voter support
- Earns over \$100 million in tax revenue per year
- Only 4.5% of funds are spent on administrative costs, with just 1% going toward staff costs
- 40% of funds to Capital Projects: 8 of 27 capital projects complete
- 60% of funds to Programs: operations, maintenance, and improvements for mass transit, streets and roads, bicycle and pedestrian safety, senior and disabled transportation, and transit oriented development
